It will enable participants to apply their theoretical learning into practice during the hands on training in the classroom. It will also allow the participants to apply their skills in professional work environments at the hospital emphasizing the participants' capability of applying know how to high quality work flow.

Program Objective:

The Central Sterile Services Department (CSSD) is divided into five major areas: **decontamination, assembly and processing, sterilizing, sterile storage, and distribution.**

The objectives of central service Program include the following:

11. Introduction of Quality Control and Assurance in the CSSD	

Number of contact hours:

The total theoretical and practicum hours are 216 hours, extended over a three months period.

- Clinical : 144 hours; (18 hours per week, 72 hours per month) for 2 months.

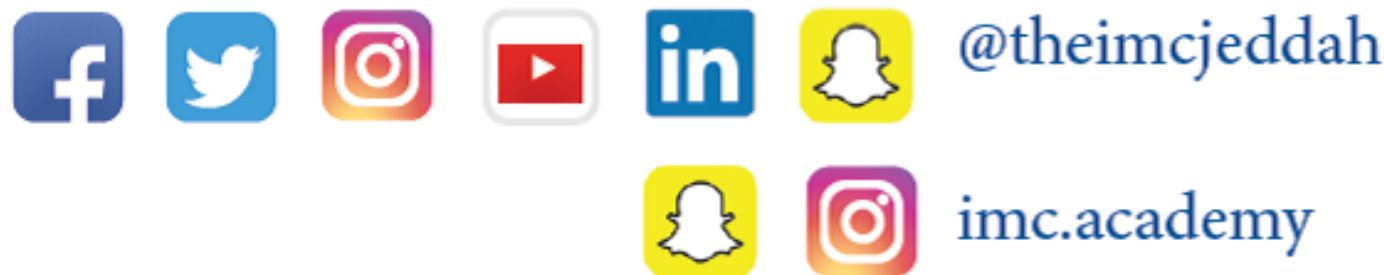
